## **Pinebrook Golf and Country Club**

is financially stable, owned by 500 shareholders, and operates with an elected Board of Directors ensuring fiscal responsibility and understanding of Members' needs.



### **EQUITY MEMBERSHIPS:**

Full membership requires the purchase of an equity share. Each year approximately 20 to 30 shares, carrying full equity value, are offered for sale at a price determined by the selling shareholders.

Once you have agreed on the share price and finalized the purchase, Pinebrook then charges an Activation Fee. The Activation Fee is 50% of the agreed share price that you are purchasing plus GST.

Our shares are FULL EQUITY, so when you sell your share, you net back what you sell it for. The only part that is forfeited to the club is your Activation Fee.

Shareholders are responsible for the quarterly interest assessments on the Club's line of credit and the long term funding assessment.

### **ONE-YEAR TRIAL MEMBERSHIPS:**

Pinebrook's Board of Directors has decided to make available a very limited number of One Year Trial Memberships for the club, which include all the same benefits and privileges of current Pinebrook Members.

All of the Pinebrook facilities will be available to you during this one year trial period, so it is a great way to try out the club before making a commitment.

Prospective One Year Trial Memberships will be based on a first come first served basis to those who submit their completed application and full payment of dues. **There are a LIMITED number of Trial Annual Memberships available each year.**

**The One Year Trial Membership is only available to new Members, and is only eligible once to each family.**

### **Affiliate Intermediate Memberships: (Waiting list for 2024)**

The Affiliate Intermediate Membership is open to applicants between the ages of 18 & 37 years who do not have parents or grandparents who are equity members of the club. The number of Affiliate Intermediate Memberships are limited and determined by the Club on an annual basis.

**Board approval will be required for all memberships.**

In addition, there is a large chipping green with sand bunkers, and three bentgrass putting greens, including our new 12,000 square foot putting green. ## **Feature Group Clinics:**

Our professional staff offer private or semi-private lessons for every level of golfer. We feature weekly clinics for men, ladies, and juniors, as well as coaching for the season, which is a program focused on making serious improvements to your game. This program covers all the fundamentals of the game as well as customized coaching for the season, focusing on all fundamentals of the game. Private and semi-private lessons are also available.

Club fitting is offered from all of the major brands. Wedge fittings, putter fitting and golf ball fitting is all available as well.

### **Junior Program:**

Pinebrook has a very active junior program. The goals & objectives of our junior program include:

- Develop junior golfers who will play golf for a lifetime
- Create an environment which fosters growth for both recreational and competitive players
- Facilitate in building lifelong friendships
- Develop skills for golf and for life

Swing Into Spring Lessons are held for all children ages 5-12 (held for 4 weeks in May & June). Junior League Nights are Monday evenings. We also have a Parent/Junior Tournament, Junior Interclub, a Ryder Cup Tournament, Club Championships and other fun events.

## MEMBERSHIP CATEGORIES:

### Primary Members:

A Primary Member is the owner of the share, or in the case of a Corporate share, the nominee playing on the share. The Primary Member has voting privileges at Shareholder meetings and can serve on the Board of Directors.

### Associate Members:

A Primary Member can choose to set up their spouse and children and/or grandchildren as active playing Members for the season by paying their applicable annual dues (see below). You may choose to set up your spouse and children and/or grandchildren on a year by year basis. Each child and/or grandchild of a Member is eligible to play under their parent / grandparent's share until the age of 37.

### Social Members:

A Social Member can utilize any of our dining facilities as often as desired, and may also bring guests provided the Social Member is present. Social Members can also attend any non-golf events (i.e., live music evenings, special occasion brunches, etc.). An 18% Service Charge is added onto all charges for Social Members; no further gratuities are required. There are a limited amount of social memberships available each year.

## Annual Dues:

Annual Dues are charged on your January Statement each year and are due in full by the end of February. If you purchase a share during the season, the dues will be pro-rated.

## NOTES:

- Intermediate memberships are for those individuals whose parents or grandparents are Equity Members.
- Affiliate Intermediate memberships are for individuals without a parent or grandparent as an Equity Member.

A credit check is required for all new members.

Direct auto withdrawal (Pre-authorized debit) is required for all non equity memberships.

**Lockers are an additional fee at a yearly cost of \$49 for a half locker, and \$75 for a full locker.**

All prices are subject to GST.

**NO monthly minimums!** We have NO monthly minimum in the Lounge and Clubhouse. Included in your Annual Golfing Dues is a Service Charge which covers all the food and beverage gratuities for the year. We want you to choose to come and dine in our facility!

## **FOOD & BEVERAGE:**

As a Pinebrook Member, you are welcome to use the club for a private or corporate function of your own; simply contact our Catering & Banquets Manager to make arrangements. At Pinebrook, we are dedicated to being your ultimate choice of venue, with our first class dining and personalized service, and a clubhouse that can accommodate groups of up to 200 people. Our extraordinarily picturesque venue features breathtaking views of the mountains, river valley and various vistas, offering ideal settings for a wedding, corporate tournament, special occasion, or meeting/seminar. Our award winning culinary team brings years of creative experience, and offers a very innovative menu to satisfy all of your catering needs, as well as customized menu selections.

Our upstairs Members Only area features our Garden Terrace for your finer dining needs, as well as our spacious Lounge and Mountain View Patio, which is perfect for relaxing in after a round of golf. Our Executive Chef creates menus that are sure to please everyone in the family, monthly menu specials as well as themed dinners. During the golf season we have live music on the patio (or inside the lounge) once a month.

## **DRESS CODE:**

The Members of Pinebrook require that all persons using the club premises be appropriately dressed. Therefore, Pinebrook Members and guests are required to honour this policy, which may change from time to time. Our Directors have asked the Golf Shop staff and Clubhouse Management to enforce the dress code.

## **We consider golf sportswear to be minimum attire. This includes:**

- Tailored, pocketed dress slacks or shorts that have an inseam of at least 5 inches;
- Men's golf shirts must have sleeves and a styled collar (dress, polo, turtleneck or mock-turtleneck, mock collar, blade collar) and may be worn untucked only if designed to be untucked. Men's dress shirts that have a tailored hem may be worn untucked if designed to be untucked, in **CLUBHOUSE AREAS ONLY**.
- Ladies golf shirts must have either sleeves or a collar.
- Dress denim must be in good repair and fit appropriately, and will be permitted in the clubhouse, locker room, lounge, patio, main dining functions, golf shop and parking areas only (not on the course or practice facilities), but may be restricted at special events with advance communication.
- Golf attire as above, dress denim, or proper cocktail/evening dining attire is acceptable in the Garden Terrace.

## **We do not permit the following on our premises:**

- Short shorts, halter tops, collarless tee shirts, sweatpants, tracksuits, workout wear, clothing that exposes midsection flesh, logos that could be considered offensive, hoodies, backwards headgear, cut-offs, denim that is low cut, torn, has frayed ends, holes or is overly faded, painter pants, overalls, or any attire of a similar nature.
- Hats worn backwards.
- Hats are not permitted to be worn in the Clubhouse.

**During the 10 days of Stampede, the dress code will be relaxed to permit the wearing of western wear and denim in the food and beverage areas.**

### **CELL PHONE USAGE:**

Members are permitted to carry their cell phones while at the Club. However, the following rules apply to Members and guests:

- Cell phones must either be turned off or be in silent/vibrate mode in all areas,
- Talking on cell phones is restricted to the parking lot, halfway house, and places within the clubhouse that do not disturb other Members,
- An effort should be made to move to a quiet location before talking on a cell phone.

### **SMOKING/CANNABIS/MARIJUANA:**

Pinebrook is a non-smoking facility. Smoking (including the use of electronic cigarettes) is not permitted within any buildings or patios. Smoking areas and cigarette butt receptacles are located 6 meters outside all entrances. On course smoking is discouraged. Smoking refuse should be removed once fully extinguished and not left on the grounds. The sale or consumption of cannabis (either edibles or smoking) is not permitted on Pinebrook property.





# HOW TO FIND US

Pinebrook is centrally located in the rolling foothills just off of Lower Springbank Road, just 20 minutes west of downtown Calgary.

**Construction of the Southwest Calgary Ring Road (SWCRR) has caused some detours and/or permanent road closures which may affect your planned route to the Club.** Drivers are advised to use 17 Avenue S.W. as the best access route. Checking the SWCRR website for current updates would be prudent to ensure that you're not late for your tee time!

- Take 17th Avenue westbound. Continue through the first traffic circle at Slopeview Drive and through 2 sets of lights until you reach another large traffic circle.
- Take the traffic circle and exit onto Lower Springbank Road East.
- Continue for 1.3 km, then turn right onto Pinebrook Way. You will see the "Pinebrook Estates" sign at the front entrance.
- Follow that road to the Clubhouse.

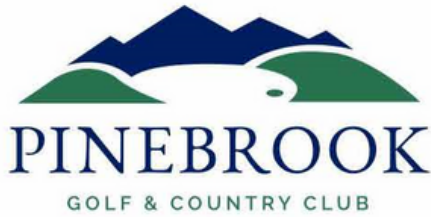

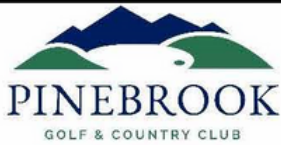
